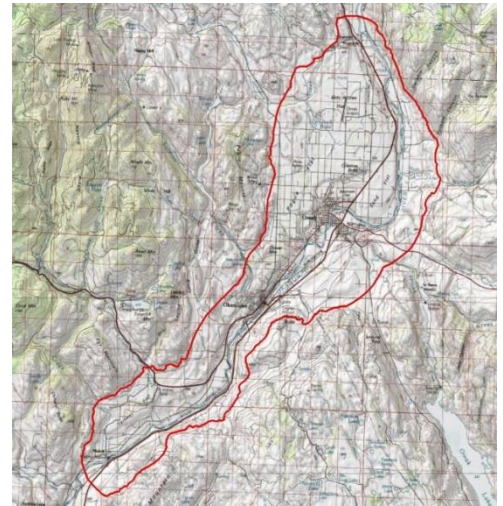




Confederated Tribes of the Colville Reservation Air Quality Program 2019 Woodstove Replacement Program

This program intends to replace older non-certified woodstoves with EPA cleaner burning certified models to promote a healthier community. The area shown on the map extending from Riverside to Malott along the Okanogan River often has measurable smoke concentration during the winter heating season that may be harmful to our health. By replacing inefficient stoves with efficient models these smoke levels can be decreased.

A woodstove replacement campaign is a voluntary, incentive based effort to encourage owners of old, inefficient woodstoves to replace or “change out” their stoves with cleaner burning pellet or certified woodstoves. Woodstove changeout campaigns have proven to be an effective solution to improving air quality in many areas.



Woodstove Replacement Boundaries

Cooperating partners involved in organizing this campaign included U.S. Environmental Protection Agency (EPA), Okanogan County Community Action Council, Colville Tribes Low-Income Home Energy Assistance Program (LIHEAP) and the Okanogan River Airshed Partnership.

Qualifications for participation in replacement program

1. The wood stove must be uncertified
2. The woodstove must currently be used to heat the home
3. Only wood or pellet stoves offered as replacement and installation through this program qualify. Other stoves or installers are not eligible under this program.
4. The applicant must live in the home and be the owner
5. Only free standing appliance will be replaced, fireplace inserts do not qualify

Applications will be screened by the Air Quality Program and a home visit scheduled to confirm the stove status. Once the applicant is approved to participate in the program a contractor will contact them to setup a visit to determine the next steps needed to complete the installation of the new stove. The applicant will have a choice of several models of wood and pellet stove to be installed.
