PROPOSAL: The demolition of 3 existing structures and construction of one new structure to

house the Okanogan County Sheriff's Department's equipment storage and house

the County's permanent morgue facility.

SITE: 269 Railroad Avenue, Okanogan, WA 98840; also known as, Parcels:

3326160026 & 1380110000; TAX 26 PT LOTS 3,4 & SE NW, PT VAC OKANOGAN ST NE40.9FT LOT 11, LOTS 12 THRU 15, PT VAC RD LY N OF SUSANNES ADD OKANOGAN (GARAGE) Section 16 of Township 33 N., Range 26 E.WM, within the City of Okanogan, Okanogan County,

Washington, and on the Colville Confederate Tribal Reservation.

The Subject Property lies within the 100 year floodplain and within 200' of the Okanogan River's OHWM and/or floodway landward boundary and/or its associated wetlands.

While the Okanogan River is defined as a shorelines of statewide significance (WAC 173-18-280), the Subject Property is located within the boundaries of the Colville Reservation, which is excluded from state shorelines jurisdiction.

The project site is designated by the Colville Shoreline Master Program as being located within **Conservancy and Upland** designations.

The City of Okanogan completed a review of the applicant's State Environmental Policy Act Checklist (SEPA) and issued a Determination of Non-Significance (DNS) in accordance with WAC 197-11-340(2) on June 7th, 2023. Public notice of the SEPA DNS was issued also on June 7th, 2023. The 15-day public SEPA comment period ended June 22nd, 2023, and the SEPA appeal period closes on July 3rd, 2023. To date no comments have been returned.

A public hearing on the proposal will be held before the City of Okanogan City Council on the **2nd** of **January 2024**, at the hour of 7:00pm At City Hall Chambers or remotely via Zoom.
